DOCUMENTS NEEDED TO APPLY:

- Proof of Income:
 - Proof of gross income from all household members for the 30-day period prior to the application date. (LIHEAP AND ComEd HARSHIP)
 - Annual income for each member of the household 16 years and older (WEATHERIZATION PROGRAM)
- Current copy of heat and electric bills (if you pay for your home energy directly)
 - Bill must show rates and meter readings
 - The date of the utility bill must be issued within the last 30 days. (ComEd Hardship Program pays up to \$1,000 NOT EXCEEDING PAST DUE AMOUNT)
- Proof of Ownership of the dwelling - current tax bill, mortgage statement or recorded mortgage. (WEATHERIZATION PROGRAM ONLY)
- Proof of Social Security Numbers of all household members
- Picture ID (ComEd HARSHIP PROGRAM ONLY)
- If a member of your household receives TANF, you must bring their Medical Eligibility Card
- Applicants that have their utilities included in the rent must bring proof of rental agreement stating monthly rental amount, that utilities are included, and landlord contact information. (Rent costs must be greater than 30% of household gross income for 30 days prior to application).
- Please provide documentation for all circumstances. Proof of all hardships must be within 6 MONTHS. Disability proof must state disability and show monthly amount. Disconnected and finaled accounts will not be credited. (ComEd HARSHIP PROGRAM ONLY)
