A *special \$100 early bird registration fee* is being offered for the month of March 2010. If you register your child and pay IN FULL by March 31, the cost will be \$100 per child.

Returning players and cheerleaders receive a **\$10.00 discount** if they register before June 1 (offer does not apply to children registered at the \$100 early bird rate).

Registration fees do not include equipment packages that must be purchased for football players and cheerleaders. Equipment packages are sold separately.

PLEASE NOTE: Families with 2 or more children in the program are NOT required to sell more than \$120 in raffle tickets. A payment plan can be arranged when signing up more than one child prior to the beginning of the season. Full payment must be received before June 1, 2010 (\$50.00 Minimum Deposit Required).
